ORDINANCE 2015-10

AN ORDINANCE AMENDING ORDINANCE 2014-05, AN ORDINANCE REESTABLISHING A SANITATION UTILITY, SECTION 8, COUNTY LANDFILL FEES AND CHARGES; TO CHANGE CURRENT COUNTY LANDFILL FEES SET BY THE COUNTY COMMISSIONERS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEOTI, KANSAS, THAT ORDINANCE 2015-05, SECTION 8 SHALL BE AMENDED AS FOLLOWS.

Change County Landfill Fees and Charges to the amounts below.

Current County Landfill Fees as Set by the County Commissioners Effective October 1, 2015	
Single (residential/structure)	\$8.92 per month
Light Business	\$11.88 per month
Medium Light Business	\$15.86 per month
Medium Business	\$19.79 per month
Medium Heavy Business	\$23.77 per month
Heavy Business	\$27.74 per month

BE IT FURTHER ORDAINED, that the rates above replace rates currently in existence and to be reflected on monthly city utility statements moving forward effective October 1, 2015.

BE IT FURTHER ORDAINED, This Ordinance shall be effective from and after its passage and publication in the official City newspaper.
