ORDINANCE 2015-11 SUMMARY

Notice is hereby given that the Governing Body of Leoti, Kansas, did, on November 2nd, 2015, pass and adopt Ordinance 2015-11 AN ORDINANCE AMENDING ORDINANCE 2014-05, AN ORDINANCE REESTABLISHING A SANITATION UTILITY, SECTIONS 5 AND 6, SANITATION RATES INSIDE CITY LIMITS AND SANITATION RATES OUTSIDE CITY LIMITS; TO CHANGE CURRENT SANITATION RATES FOR CUSTOMERS INSIDE AND OUTSIDE CITY LIMITS. ORDINANCE 2015-11

AN ORDINANCE AMENDING ORDINANCE 2014-05, AN ORDINANCE REESTABLISHING A SANITATION UTILITY, SECTIONS 5 AND 6, SANITATION RATES INSIDE CITY LIMITS AND SANITATION RATES OUTSIDE CITY LIMITS; TO CHANGE CURRENT SANITATION RATES FOR CUSTOMERS INSIDE AND OUTSIDE CITY LIMITS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEOTI, KANSAS, THAT SANTIATION RATES WITHIN CITY LIMITS SHALL BE RAISED 12%, AND THAT OTHER RATES NOT LISTED BELOW SHALL BE RAISED 12%, AND THAT THAT ORDINANCE 2015-05, SECTION 5 SHALL BE AMENDED AS FOLLOWS.

BE IT FURTHER ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEOTI, KANSAS, THAT ORDINANCE 2015-05, SECTION 6 SHALL BE AMENDED AS FOLLOWS

Residential Outside City Limits	
As of Dec. 1, 2015, Residential Minimum Monthly Sanitation Charge	\$26.10

Commercial Outside City Limits	
As of Dec. 1, 2015, Commercial Class A Minimum Monthly Charge	\$29.88
As of Dec. 1, 2015, Commercial Class B Minimum Monthly Charge	\$40.00

As of Dec. 1, 2015, Commercial Class C Minimum Monthly Charge	\$50.16

BE IT FURTHER ORDAINED, that the rates above replace rates currently in existence and to be reflected on monthly city utility statements moving forward effective December 1, 2015.
